RE: 2025 Plumbing Registration for Carroll County

Enclosed is the application to register or renew your Plumbing Registration for 2025. The fee to register as a Plumber is **\$70.00**. Plumbers must be registered before they can do work in Carroll County. If a plumber continues to work in Carroll County in 2025 prior to becoming registered, there is a **200%** penalty fee of the permit.

To complete your registration, the following information **must be submitted to our office**:

- Completed Application and Fee
- Proof of General Liability & Power of Attorney
- Original Surety Bond dated through January 31, 2026
- Copy of your State Plumbing License

Please take note that if a 2024 Carroll County Plumbing Registration was obtained, a continuation bond is acceptable but must be dated through January 31, 2026, and the application does not need to be notarized.
